Because of the current uncertainty, the CALQ is studying applications to arts presentation support programs on the basis of the project production date, with priority to projects scheduled to begin soon. There is no advantage to submitting an application far in advance or an application covering a very long period.

The CALQ cannot guarantee **response times** indicated in the program information will be met.

For all programs, it is the responsibility of applicants to demonstrate their project's feasibility in view of COVID-19 restrictions. **Contracts and letters of agreement attached to applications must reflect that consideration**. Failure to meet this expectation could lead to **rejection of the application**.

The CALQ also reserves the right to **deem an application ineligible** if its integrity is compromised after it is filed – for example, by the **cancellation of a festival** or the **closing of a venue** that is on the program.

Applications will not be accepted by mail until further notice.

The Diffusion d'œuvres à l'extérieur du Québec, Développement des organismes à l'extérieur du Québec and Prospection programs reopen on July 5, 2021.

To facilitate the decision-making process, please submit your application only when you are certain that the project or program of activities as submitted is feasible. Factors that may make it possible to complete them include:

- the official re-opening of the sector (as decreed by government authorities);
- the signing of contracts.

By submitting an application for financial aid under these programs, the applying organization accepts the following responsibilities:

- Travellers to another Canadian province or another country:
 - have consulted the COVID-19 information website of the destination province our country and are able to comply with the travel rules in force at the time of their trip;
 - are aware that they must conduct their professional activities in accordance with the workplace rules, standards and protocols in force at the time of the activities;
 - understand that they will have to cover any unexpected expenses in the event of sudden changes arising during the trip (expenses related to quarantine, emergency return, closing of borders, etc.);
- Travellers returning to Canada understand that they must follow the rules established under the emergency orders, particularly those described on the official <u>Government of Canada site</u>;
- Any costs arising from a quarantine are not eligible expenses.

Travellers outside Québec must have travel insurance covering emergency medical care, including risks associated with the coronavirus (COVID-19), for the entire duration of the trip. In this regard:

- All grant applications must include insurance costs in the budget. **Otherwise, the application will be deemed ineligible**.
- A representative of the recipient organization must sign a letter of agreement stipulating, among other
 things, that it is the organization's responsibility to purchase and maintain the appropriate insurance
 policies, including civil liability and medical insurance, from a recognized insurer, as the CALQ
 assumes no responsibility of any kind to the recipient organization. The awarding of the grant by the
 CALQ entails no liability on its part and the managers of the recipient organization are solely
 responsible for their actions in connection with the use of the grant.
